

Pre-Installation Note

9039-270 Emergency Cable Bracket Kit is designed to be used with QA1 C10 Truck arms and OE emergency cables.

Installation Instructions

- 1. Raise and support the vehicle on a stable surface.
- 2. Hold the cable up to the truck arm to find the approximate location for the brackets to mount.
- 3. Loosely install the brackets on the truck arm as they will need to be adjusted slightly to line up with the cable.
- 4. Insert the leading edge of the cable into the rear opening and install the OE retaining clip.
- 5. Position the clamp so the brake cable is out of the way of any moving components and tighten the bolts.

6. Repeat on the other truck arm and test the emergency brakes. Remember, the cables may be rusted and your brakes may be stuck applied. If the emergency brakes were not trusted before the suspension change they will not have gotten better.
